**Re: Section 106 Funding Agreement with Walton Community Council – Construction of a Community Pavillion at Browns Wood Sports Ground**

I can confirm that Milton Keynes Council will pay the sum of £111,084.04 to Walton Community Council for the purposes of providing construction of a Community Pavilion at Browns Wood Sports Ground for the benefit of the residents of the Land South of Intervet Campus Off Brickhill Street Walton Milton Keynes development.

By accepting this payment you are agreeing to be bound by the following terms to be accountable to Milton Keynes Council to ensure this contribution is spent in accordance with the Section 106 Agreement dated the 20<sup>th</sup> of September 2006 with reference 06/00490/OUT.

This means that you will be accountable legally to Milton Keynes Council, so should any challenge arise from the developer or a third party regarding this contribution, you agree to work with Milton Keynes Council to assist resolve any such challenge/dispute.

**It is hereby agreed between Milton Keynes Council (MKC) and Walton Community Council;**

- 'The Contribution' means the sum of £111,084.04
- 'The Development' means the Land South of Intervet Campus Off Brickhill Street Walton Milton Keynes
- That The Contribution allocated to Walton Community Council is to be spent on providing facilities and services in Milton Keynes.

That the following expenditure restrictions are complied with:

**Expenditure of the Contributions:**

Walton Community Council covenant with the Council that it shall:

- Hold The Contribution in a dedicated interest bearing account;
- Apply or expend The Contribution wholly and exclusively for the purposes respectively for which the same were paid as specified in the provisions of this Funding Agreement;
- Spend the entire Contribution by the **31<sup>st</sup> October 2019** and repay any such sum or amount remaining unexpended by no later than the **30<sup>th</sup> of November 2019** to Milton Keynes Council, unless otherwise agreed with the Council.
- The Council reserves the right to contact you at any time requesting a breakdown as to how The Contribution has been applied and you agree to provide this information within 14 days of such request.
- You shall provide the Council with a written statement as to how The Contribution has been applied no less than every 12 months on the anniversary of the date of this Funding Agreement, and shall provide the Council with a written summary of how the money has been spent upon expending all of The Contribution.
