**Disqualifications:** Apart from meeting the qualifications for standing for election, you must also not be disqualified. You cannot be a parish councillor if:

- You are employed by the parish council or hold a paid office under the parish council.
- You are the subject of a bankruptcy restrictions order or interim order
- You have been sentenced to a term of imprisonment of three months or more (including a suspended sentence), without the option of a fine, during the previous 5 years.
- You have been disqualified under the Representation of the People Act 1983 (which covers corrupt or illegal electoral practices and offences relating to donations)

The disqualification for an illegal practice begins from the date the person has been reported guilty by an election court or convicted and lasts for three years. The disqualification for a corrupt practice begins from the date a person has been reported guilty by an election court or convicted and lasts for five years. A person may also be disqualified if they have been disqualified from standing for election to a local authority following a decision of the First Tier Tribunal (formerly the Adjudication Panel for England) or the Adjudication Panel for Wales.
